MESSAGING STANDARDS TO BE USED THROUGHOUT THE NHS

In April 2014 the UK Department of Health published its eProcurement strategy for the NHS. A key element of the strategy was to mandate the use of the global GS1 coding and PEPPOL messaging standards by 2018, throughout the healthcare sector and its supporting supply chains.

During 2016, trials of the use of the GS1 and PEPPOL standards at a range of NHS Trusts up and down the country have resulted in significant efficiencies and cost savings, reduced errors and improved patient outcomes and patient safety. These trials are to be expanded to a wider group of Trusts and their supply chains during 2017. When the strategy is rolled out across the NHS it is predicted to save billions of pounds, to be re-directed into frontline healthcare services.

THE DEADLINES

The NHS eProcurement strategy provides a timeline for all NHS bodies to move to electronic trading using PEPPOL standards. By March 31st 2018, all suppliers must be ready to receive orders from NHS access points, and by September 30th 2018, all parties must be ready to manage all their ordering and invoicing using PEPPOL standards.

Of course these are final deadlines and there is preparatory work required to become fully enabled, so many Trusts and their suppliers are already making plans. And the sooner organisations begin using the standards, the sooner the savings and efficiencies will be realised.

WHAT IS PEPPOL?

PEPPOL - Pan-European Public Procurement Online - defines technology standards and infrastructure that enable governments, public sector organisations and businesses to communicate electronically in the procurement process, increasing efficiencies and reducing costs. Documents are exchanged between access points in the PEPPOL infrastructure, with each trading partner listed in a common directory.
